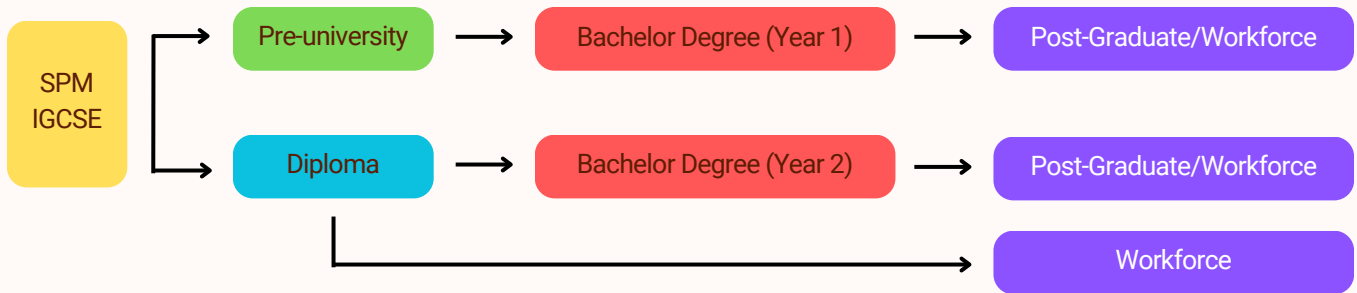

General Entry Requirements

- **A-Level:** Minimum EE/equivalent of 80 points
- **Ausmat/SACEi:** Minimum ATAR 60
- **CIMP:** Minimum average of 60% in any 6 subjects
- **Foundation/Matriculation:** Pass with CGPA of 2.00
- **International Baccalaureate (IB):** Minimum 24 points in 6 subjects
- **UEC:** Pass with 5Bs in including Mathematics and English
- **STPM:** Minimum 2Cs with minimum CGPA of 2.00
- **Diploma in Business:** Minimum CGPA of 2.00

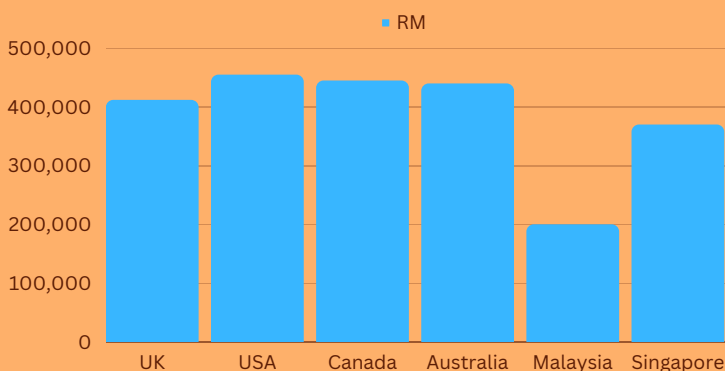
