


BHMS Internship Placement

During each academic year, the majority of programs require that students successfully complete a 4-6 months internship period in a hospitality business approved by BHMS. Internship placement managers assist students with placements in hotels and restaurants both in Switzerland and overseas. During the internship, students will be under L-GAV contractual obligation with their employers, which will entitle them to receive a trainee's gross monthly salary of **CHF2,303** if undertaken in Switzerland. Employers make deductions for room, board and taxes from the gross monthly salary. To qualify for internship, students are expected to meet specific academic, professional, and language skills standards set forth by BHMS. During internship, students' performance, behaviour and professional attitude will be assessed by employers and students are required to submit a report about the nature and management of the property in which they had their internship.
